Guarantee Pricing

Minimum "Guarantee" is generated upon total sales for time committed. There is no restriction upon "how" the guarantee is met, only that any shortage in purchase will be added to meet the minimum amount. The minimum guarantee does NOT include an automatic service charge of 18%, nor does it include tax. *The Minimum Guarantee Pricing is set for normal business days and is subject to change during special events.* Maximum Seating: 40 - 45 dining chairs and 12 - 15 tables.

Lunch Service: 11am to 4pm
Monday to Sunday = \$200 minimum

Dinner Service: 4pm - Close
Sunday to Wednesday = \$300 minimum
Thursday to Saturday = \$500 minimum

Reservation Requirements

Please call Management at 408-445-2121 with any questions regarding your group reservation. Reservations can be made 3 months in advance and are based on availability. Please plan ahead as popular dates and times book quickly.

A credit card is required to hold the reservation. It will not be charged at time of booking or event. Please include a photocopy of both sides of the CC to be used for reservation. Again, no parties under 21 years of age allowed unless there is prior arrangement and approval in writing from management.

A group reservation is not confirmed until Rookies Sports Lodge has received and approved the following completed and signed contract from the group coordinator.

One Check Final Payment *If no private bartender is requested*

Final payment is due at the end of the event. One check will be issued, no split checks will be issued for any table in the back room. Event coordinator is responsible for collecting final payment. Once minimum is met, rules do not change. ONE CHECK. Multiple payments and separate tabs are available only if a private bartender is requested. All tabs will go towards the party's "minimum spend".

Cancellation & No-Show Policy

Groups have 72 hours prior to their reservation to cancel by emailing michael@rookieslodge.com. A charge of \$250 will be applied to the credit card ONLY if the group does not cancel within 72 hours and does not show up at the time of the reservation.
